Acacia Fraternity Heth Chapter at Crossroads of Restructure Alumni Involvement Critical to Success

Many Board members became involved with the Corporation in the early 1990's to rebuild and ensure the future of the Heth Chapter at University of Illinois. As time has passed, our Alumni are coming back. I am proud to see that our brotherhood has not lost sight of the Acacia bond.

Board and Alumni plans to move forward in Spring 2003 with efforts to purchase the current Chapter house at 907 S. Third St. were cut short, at least for right now. The University Greek Affairs office, working proactively, informed us in Spring 2003 of signs of membership trouble. The shift to younger Chapter leadership Greek-wide, a generation of students with higher lifestyle expectations, and apartment living, has posed leadership, operational and financial difficulties for the Chapter. Critical to our resolution of the issues facing the Chapter, the Board has worked closely with the Chapter and University and issued a series of directives that focus on member development, accountable operations, and accountable membership in all aspects of the Fraternity. Heth Chapter of Acacia is currently engaged in a major restructuring in response to the Board's directives. The Board believes the Chapter is committed to achieving the goals of the restructuring and has shown some good progress.

WE ARE, HOWEVER, AT A CROSSROADS. Your financial support has been vital to our success. The Board believes there are still opportunities to structure a purchase scenario for the Chapter house, if that is the direction our Alumni want to take. <u>However, we really need your SERVICE to the Chapter to shape Acacia's future</u>. You can help provide others the same opportunity to build the relationships, values and character that Acacia Fraternity has fostered in our accomplished Alumni. **Jay North '90** and I have been pleased to serve for well over 10 years, but we must have more regular involvement and rotation among our Board. The Board this year will be adding members and holding elections for officer positions within Corporation Board. As you will read in this edition, the undergraduate Chapter is undergoing a reorganization that will revitalize and strengthen the membership and operations of the Heth Chapter of Acacia Fraternity going forward.

Undergraduate Report

As venerable dean this year and a junior academically, I have focused most of my attention on leadership. Since induction, we have been working very closely with the corporation board to restructure the chapter. I am very confident our membership will continue to improve and that we will continue to be one of the strongest fraternities at the University of Illinois. The men of the Heth Chapter are very motivated individuals and are ready to produce more positive results this spring semester.

The chapter has implemented some positive initiatives. In following the most important Acacian value — human service — last fall our chapter completed 150 hours of community service, and we have set a goal of 250 hours of community service for this semester. We initiated our fall pledge class of 18 members this January 2004 and had one of the highest initiating pledge class GPAs on campus. Our current enrollment is 85 members. Unfortunately, the chapter made the difficult decision to deactivate eight members due to their lack of respect for Acacian values. We believe this step will help the chapter focus on a positive future. We will be at full in-house capacity for the fall 2004 school year and feel that our core brotherhood represents what Acacia stands for.

We recently sponsored an alumni event at a restaurant in Chicago attended by about 75 alumni. Most of the alumni were from the 2000-03 classes (thank you very much for coming out), but we would love to hear from older alumni as well! We will be holding two alumni events this semester and are planning a very large Acacia reunion in Chicago for fall 2004.
