Details, Details, Details!

In order to return 302 E. Armory to its original fraternity house purpose, work will need to begin immediately after closing the purchase and possession is finalized.

Ken Wagner '55, a retired Acacia Illinois architect, is heading up the planning and implementation of what has come to be dubbed "the manning up process". A committee of active chapter members met with Ken to provide the Chapter's input in that process so that Acacia Illinois will have the facilities needed and desired by today's fraternity college students.

The Alumni Corporation Board has authorized funding for \$45,000 worth of alterations and improvements slated postclosing. Approved improvements include: first floor painting; new floor coverings;

exterior handrail assembly and repair; shower curtains replacement in the bathrooms; removal of old signage and the addition of Acacia metal letters. All changes are expected to be completed prior to student movein early August 2012. Watch for progress photos in future editions of *The Hello*.

Improvements for the following year will cost approximately \$50,000. Constructing a more congruent connection between the original house and the annex, which would add 747 sq ft of additional living space as currently contemplated on the Armoryside of the house (later), could add another \$150,000 when constructed. Changes to be made in the second year will be outlined in the next edition of *The Hello*.

"Manning Up" for Fall 2012 Occupancy

The Chapter is doing its part by insuring the house is filled with at least 58 residents this fall. While the Beta house accommodated only 47 chapter members, the University housing authority established the maximum residents at 302 E. Armory to be 72 (with the current, larger "dorm room" configuration). The Chapter and Alumni Corporation Board have tentatively concluded

that 64 residents can be comfortably housed in a desired configuration, and collectively set an objective goal of 58 live-in members for the fall semester.

Many in the spring 2014 pledge class will likely move into the new house and thus become the part of a prestigious "first year residents list", which may be posted for years to come on the walls of Acacia Illinois.

Chapter Developing Updated Budget

Acacia treasurer, **Sam Moore**'10, along with fellow chapter officers and alumni chapter treasurer liaison, **Harrison**Pappas '05, are working diligently to structure the house budget based on our new home for the coming school year.
Key factors include the larger "live-in" capacity and related cost increases and expenses previously covered by Acacia's

soon-to-be former landlord (Betas).

The good news for active members - with at least 58 live-in actives, there will likely be only a minimal increase in house bills (if any) depending on the number living in the house. Historically, Acacia's house bills have remained competitive with University dorm lodging and food costs.

Bank Financing in Progress

Alumni who have followed Acacia's property acquisition process know that funding is required to eventually have a mortgage-free property. Meanwhile, more work is required.

Mike Duncan '74 has assumed the responsibility of obtaining a mortgage at favorable terms, and is

evaluating multiple proposals from various banks, along with assistance from Michael Conniff'93 and Art Mertes '85.

Acacia will invest a substantial portion of the funds already collected in the first phase of the Capital Campaign, while leaving adequate reserves for other needs.

Purchase Details Nearing Final Phase

Those alumni exposed to the nitty-gritty details of any real estate closing are well aware of the myriad of details involved in concluding and ultimately closing on a purchase.

Such has taken an immense amount of time by **Mike Duncan '74**, who fortunately for Acacia Illinois has had a

life career of negotiating such purchases. By the submission deadline for this edition of *The Hello*, contracts were signed, security deposits were provided, inspections were completed and some funding applications were submitted. By print and delivery times, we expect to be even further along.



Daily Illini Documents **Acacia Illinois Purchase**

On February 14, 2012, the *Daily Illini* printed an article on Acacia's planned house purchase.

The article stated that "Acacia has been looking for a property to buy for their members for the past seven and a half years."

Though the *Daily Illini* staff queried Alumni Corporation Board Members, no comments were made other than those attributed to **Mike Duncan**

'74 and identified in the article as chairman of the Real Estate Search Committee of the Alumni Board.

The *Daily Illini* quoted Mike, in part, as saying: "During this time we've evaluated 31 different properties in Champaign and Urbana and we narrowed it down to ten finalists and aggressively pursued three of those."

Roadmap to Success

Unless you have a reliable GPS, making a trip to some distant point without a roadmap is unwise. Acacia's pro forma statement details our financial roadmap to insure success and help secure lending.

Art Mertes '85, with assistance from past Alumni Corporation Board member Dennis Bone '02 and other current board members, drafted and revised Acacia's pro forma. Board members remember our alumni's admonition from more

than seven years ago which paraphrased:

"You cannot be successful and expect alumni support in the absence of a realistic pro forma statement."

Yes, the banks expect the same as well. Acacia's pro forma concentrates on developing a justifiable financial roadmap to the future. Input from a wide variety of sources and the pathway to financial stability is clear.

Imagine the paperwork and complex legal documents and jargon involved in a house purchase. Development of the original documents and the drafting and re-drafting of complex statements has been an ongoing task.

Attorney **David Thies '73** with support and counsel from attorneys **Adam Powers'98** and **Art Mertes '85** has resulted in

Acacia Illinois being not only well guided but fortunate to have this valuable help without cost.

Ron Slonneger 1935 - 2012

Ron graduated from the University of Illinois with a mechanical engineering degree and later obtained an MBA. A native Peorian, Ron worked for Caterpillar for 41 years and retired in 1995. Ron and Jean shared a passion for sailing and were actively involved in sailing with the Peoria IVY Club. For 11 years following retirement, Ron and Jean spent several months each year sailing from the Great Lakes to the Bahamas and back.

Charles E. (Chuck) Yale: M.D., D.Sc. 1925 - 2010

The following information was obtained from the obituary of **Chuck Yale '43** who died at home in Mesa, Arizona on November 7, 2010. Chuck is survived by his wife Helen, four children, thirteen grandchildren and four great-grandchildren.

Chuck served as a pilot in the US Navy from 1943-47, before enrolling at University of Illinois, where he earned an Engineering Physics degree in 1949. Chuck married Helen Whitson in 1948 and the couple moved to Cleveland, Ohio where he attended medical school at Case Western before completing nine years of surgery residency and fellowship at the University of Cincinnati School of Medicine.

Before retirement, Chuck had been Professor of Surgery Emeritus at the University of Wisconsin School of Medicine in Madison, Wisconsin where he established the Gnotobiotic Laboratory to study bowel obstruction in germ free rats. Chuck was one of the developers of gastric surgery for the morbidly obese.

Chuck served as Acacia Venerable Dean from 1948 to 1949.
