Man-Up Project Completed

"Man-Up" is the name given to the ultimate task of returning a former sorority house to its fraternal roots as the new chapter house for Acacia Fraternity at the University of Illinois. The house, built in 1929 for Theta

Upsilon Omega Fraternity, became a sorority in 1946.

Planning began in January 2012, soon after the Corporation Board (the "Board") signed a contract to purchase 302 E. Armory. Plans were completed by April 3, when Acacia took possession of the property. Contractors were invited to review the plans, inspect the property and submit bids for the work. A contractor was selected and the work began immediately. A budget of \$200,000 was established by the Corporation Board for the project. It was completed under budget for a total cost of \$184,953.40.

A review of current study habits and behavior indicated a change from what many of us experienced a few years ago as students. The electronic age with internet access, rapid communication and information systems has transformed how, when and where students study. While some study in their rooms, many prefer to study in separate designated study areas or offsite. They use their rooms only for sleeping, relaxing and watching television. A house with small two-man study rooms and separate dormitory sleeping accommodations is no longer popular or desired. A variety of room sizes is preferred; single, double, triple and even quad. The new Acacia house has 15 single rooms, 18 double rooms and 3 triple rooms.

Three rooms in the house have been designated "study rooms." The largest and most popular is the former sun room on the first floor. "Man-Up" added heat and light to the previously unheated and underutilized space. Students can access the internet in this room or anywhere in the house via the Wi-Fi system installed under this project.

Considerable redecorating was accomplished throughout the house to restore the fraternal ambiance that existed before its use as a sorority. The heavy timber beam ceilings in the living room and entry foyer were refinished to regain the heft and feel of a timber lodge. Floral carpeting was replaced with new vinyl plank wood flooring. Plank flooring was also used in the east wing corridors and student rooms to cover old asphalt tile floors. Paint colors and light fixtures were selected to complement the restoration.

Little change was necessary in the kitchen and dining room on the lower level - only a fresh coat of paint. The kitchen facilities and equipment are relatively new and well laid out. Tables and chairs previ-

Capital Campaign in Final Stretch - Cut-off Date Set

To date, 236 generous alumni and friends of the Acacia Fraternity at the University of Illinois have pledged a total of \$1.74 million to the \$1.75 Million Capital Campaign for the Illinois Chapter.

Proceeds received from the capital campaign, along with the \$1.7 million mortgage financing and a \$300,000 seller note due in 2015, allowed the fraternity to purchase a permanent home at 302 E. Armory. The challenge that lies ahead is having enough funds to pay off the seller note and to fund continued infrastructure investments and necessary refurbishments.

One generous alumnus has initiated a "Challenge Campaign" and has agreed to contribute \$25,000 over five years if 11 other members will join him in making tax deductible contributions over that period. Seven generous alumni have already agreed to participate. If another five individuals will accept this challenge, significant progress can be made in providing funds to relieve the \$300,000 seller note due in only two years.

The generous alumni that have given to the capital campaign will be recognized on a plaque that will be permanently displayed in the chapter house. The cut-off for being included on this list of generous donors is June 30, 2013. Please consider supporting the capital campaign and having your name inscribed, along with the other generous contributors, on this permanent reminder for future generations of Acacians to see and admire for years to come.

What's in a Challenge?

Depending on the time and the place, we suppose a challenge could be just about anything. Fortunately in the case of the "Challenge Campaign," the outcome could be quite good. Three hundred thousand is the amount of money that Acacia is obligated to pay the sellers of the new chapter house in just

two more years. This amount is in addition to the monthly mortgage and tax payment that is due every month, which is in itself a significant sum.

As you may have already read, an alumnus has volunteered to make a 5-year tax deductible pledge commitment of \$5,000 per year, if eleven other alumni will join him. Seven alumni have stepped forward to become a part of resolving this challenge

by making five year tax deductible pledges themselves.

Scholarship Award Program Being Enhanced

In recent years, Acacia has recognized members who have achieved scholastically with awards funded through the corporation budget. It is no longer unusual for the house to have six or eight students with straight A averages each semester.

Typically, Acacia member achievements have resulted in the chapter ranking in the top 14 fraternities among the 46 on campus. This is a good record, but there was an era when Acacia was routinely among the top five. Alumni have been seeking a way to help motivate a return to those levels.

The Acacia "Alumni Scholastic Achievement Program" is intended to further reward those with high scholastic accomplishments. This new program will go beyond simply recognizing those with straight A's. While details are still being finalized, the program will be much broader. For example, it is contemplated that the member with the highest grades in each

class (freshman, sophomore, junior and senior) will be an award recipient. Awards will also be given to the member who shows the greatest improvement between the first and second semester.

The program will be financed in part through the participation of alumni who want to support high scholastics and who choose to join the *Acacia Alumni Scholarship Program*.

Benefits for alumni who participate include:

- Complimentary lunch or dinner at every home football game including those who accompany him (just wear your complimentary orange "club shirt" and let everyone know you support high Acacia scholastics)
- Program support will qualify as a tax deductible donation

- An Illini orange T-shirt recognizing the individual as one of the scholastic program supporters. Wear orange!
- A special shirt designated "Founder" to the first 50 Club members. Other members will receive a standard orange "club" shirt
- Special mailings from chapter officers and Board members with up-to-date information prior to being published elsewhere
- Supporting a program that can enhance recruiting efforts
- Special recognition at Homecoming
- Pride in recognizing and supporting high scholastics at Acacia
- 90% of all funds collected in support of this activity will be used for scholarship awards

Looking to the Future

Boiler Replacement and System Improvements

Inspections that preceded the house purchase identified the need to plan for the replacement of two existing boilers in the near future. The original 1929 west wing building is heated with a 45-year old steam boiler and single pipe distribution system with steam registers located throughout the house. When the east wing was built in 1967, a hot water boiler and more modern two-pipe distribution system was added to serve the addition. Both boilers still function but are "at or near the end of their useful lives" according to consulting engineers. The boilers should be replaced with new high efficiency hot water boilers and

the distribution system in the west wing should be upgraded to current standards for better control and operating efficiency. The estimated cost is \$181,500.

Proposed Addition Between the East and West Wings

When the east wing was added to the house in 1967, it was constructed with upper and lower courtyards between the original 1929 house and the addition. Below the upper courtyard is a large multipurpose room connecting the two wings on the lower level. The upper courtyard forms an open air plaza with separate exterior entrances to the main floors of the east and west wings. According to the plans drawn for the 1967 addition, the upper level courtyard or plaza was to have been enclosed. For reasons unknown, the enclosure was never built. The Corporation Board

proposes to construct the enclosure (addition) as soon as funds are available.

The proposed addition will accomplish several things in one package. It will serve to unify the house while providing the following:

- 1. A single prominent main entrance and reception area
- 2. Greeting and gathering area for social events
- 3. Seating and conversation areas
- 4. Display of chapter achievements
- 5. Women's (guest) toilet and powder room
- 6. Indoor passage between the east and west wings

The estimated cost to build and furnish the addition is \$248,000.

Showers Rehabbed and Fire Alarm Replaced

Soon after students occupied the house last August, the venerable dean ("VD") found water dripping from the ceiling in his room on the first floor. It didn't require much investigation to find the source – the three showers located directly above the VD's quarters. The pre-purchase inspection of the house in January 2012 failed to discover this issue. A detailed inspection of the problem called for a complete rehab of the showers. The rehab successfully eliminated the leak and improved the configuration, safety and usefulness of the showers. The total cost was \$11,612.58.

Fire Alarm System

November saw the failure of the fire alarm system in the house. Four false alarms in three days led to an investigation that found the 28-year old control panel faulty. Replacement parts were no longer available. Fire system panels have changed with technology over the years as well as fire protection codes and regulations. The old panel had to be replaced with a new control panel complying with the new codes and regulations as well as all the wiring and devices throughout the entire house; smoke/heat detectors, horns, strobes, pull stations, annunciator, remote power supply, etc. The house is now protected by the most up to date fire alarm and monitoring system available and is in full compliance with the current National Fire Alarm Code (NFPA72).

The Corporation Board solicited bids from three fire alarm contractors for the project and awarded the contract to the Security Solutions Division of F.E. Moran Inc. The total cost was \$37,025.

Ron Hamelburg '57 Replaces Mel Rapp '49 as Corporation Board Treasurer



Ron Hamelberg '57 attended his first Heth Chapter Acacia Fraternity Corporation Board meeting on November 13, 2012, and was elected to the Board at its meeting on January 22, 2013. Ron

graduated with his BS degree in accounting in 1958 and became a CPA in 1961. He will replace **Mel Rapp '49** as Corporation Board Treasurer in July 2013.

Ron worked with Arthur Young & Co., predecessor to Ernst & Young, CPAs, for 15 years. He then worked for the State of Illinois government for several years. Ron finally retired after 21 years as the CFO of a faith based not for profit organization in downtown Chicago.

Ron and his wife, Nancy, have three children and seven grandchildren. Their son-in-law, **Greg Bennorth '83**, is also an Acacian, having graduated from the U of I in 1986.

Ron is very involved in serving non-profits. In addition to serving on various nonprofit Boards of Directors, he has been treasurer and/or chair of the finance committees. He is a past president of his Rotary Club and a past assistant governor of his Rotary District. Ron was a trustee of the Village of Barrington from 1989 to 1993, and president of the Village from 1993 to 2001. He is also a past president of the University of Illinois College of Business Alumni Association Board.

ously purchased for use at the Beta house were moved in and arranged. Next to the dining room is a large multipurpose room used occasionally for overflow dining, chapter meetings, recreation and informal gatherings. Both the dining and multipurpose rooms open onto the lower outdoor courtyard.

Three student rooms in the east wing were combined, renovated and remodeled to create a suite for the live-in house director. The suite includes an entrance vestibule, living room, kitchenette/dining area, bedroom and bathroom. The suite is air conditioned to provide for year around occupancy.

Exterior work included minor repairs and painting of wood trim and siding. The landscaping was improved with

new sod, plants and mulch. An existing lawn sprinkler system was serviced to keep the lawn and plants vibrant during growing seasons. The 3,600 square foot parking lot was repaved with bituminous concrete. The entrance canopy fascia sports a new name, ACACIA, in black cast metal letters. A bronze plaque recessed in the stone pier was replaced with a full color Acacia crest.

Though the project dubbed "Man-Up" is now complete, work will continue in the years ahead to meet new demands for student housing, especially those of fraternity men — THE MEN OF ACACIA.
